CALL TO ORDER: Meeting called to order at 7:07pm

- 1) REVIEW MINUTES: Bryan made the motion to accept the Minutes. Melissa seconded the motion. The Minutes were accepted.
- 2) REVIEW EXPENDITURES: Melissa made the motion to accept the Expenditures. Bryan seconded the motion. The Expenditures were accepted.
- 3) CHIEF HENDRICKS WILL TALK TO US MORE ABOUT THE RESOURCE OFFICER: Was not in attendance. We will check on this another time.

- 6) WE NEED TO GET SOMEONE TO HELP US MAP OUT OUR WATER SYSTEM: We need to make plans to map out our system to see where the lead pipes are if any. We know people in town that have been in charge when new lines were put in, so we will ask them to see what they remember. Houses built after 1989 are fine, but ones built before that need to be checked. This project needs to be done by October 2024.
- 7) JUST A NOTE TO LET US KNOW THAT WHITE'S IS CHANGING OUR HOLIDAY PICK-UP DAY FOR GARBAGE: The Clerk will advise Town Citizen's of change in pick-up day.
- 8) TALK ABOUT THE JULY 24TH ACTIVITIES: Dennis and AnaLee Marker are in charge of this 24th Celebration. There will be a 5k run, Breakfast, Parade, games and lunch. Games will include a booth for face-painting, a basketball challenge. Shirts will be sold and a sno-cone machine will be there. They are going to be doing Quilts in the building for those that want to participate. They have done a Great job and it will be a fun day.
