FAYETTE TOWN COUNCIL MEETING MINUTES

THURSDAY, MARCH 2, 2023

LOCATED AT FAYETTE TOWN HALL AT 7PM

CALL TO ORDER: Meeting was called to order at 7:05pm

ROLL CALL: Jed Bartholomew, Mayor, Bryan Lyman, John D. Bown, Melissa Mellor, Kelly Sue (on the phone)

PRAYER: Bryan Lyman

1) REVIEW MINUTES: Melissa made the motion to accept the Minutes. Bryan seconded the motion. The Minutes passed.

2) REVIEW EXPENDITURES: John made the motion to accept the Expenditures. Melissa seconded the motion. The Expenditures passed.

3) NATHAN KING WATER REPORT: Nathan said he has 2 tanks of chlorine now that are ready to go when needed. He got some Heaters for the buildings so it isn't as cold there now. He needs to Call Andrew into fix a couple of things, but all is good for now. Water levels are up and the stream is running again. Tests are all done and good. He is going to check Alora's house to see if all is ok there.

4) CHIEF HENDRICKS FROM GUNNISON POLICE DEPARTMENT: Wasn't there, but will be at our next meeting in April.

5) ELECTIONS THIS YEAR: MAYOR, JED BARTHOLOMEW, JOHN BOWN, & KELLY SUE MELLOR: The Clerk advised the 3 members that are due for re-election. They have until June 7th to decide. The Clerk will advertise for these positions that are possible to run for.

6) TRANSFER MONEY IN BUDGET-VENT FOR OFFICE, EQUIPMENT FOR WATER: We need to move some money around in the budget for the water issues. Bryan made the motion to use \$410.00 to put the vent in the office. John seconded the motion. The Motion passed. John made the motion to move \$15,000.00 into the equipment for water. Bryan seconded the motion. The Motion passed.

7) DELINQUENT WATER BILLS DUE THIS MONTH: We will go ahead with turning off water on certain houses for non-payment. We sent out letters of notice to turn water off by March 15, 2023. Kelly Sue will stay in touch with the Clerk to see who has paid by the due date.

9) BIDS FOR WEEDS-AD WAS PUT INTO PAPER: We did get one bid, but we will wait to see if any others will put in bids. We will address this next month.

10) PLANNING AND ZONING ORDINANCE AND COMMITTEE: No one has come forward for this position at this time. We will address this next month also.

CITIZEN'S CONCERNS:

Sherry Alexander addressed the Council about the problem with the cows getting out in Town and also the other animals roaming around Town. She is willing to work with John doing the Animal Control. John is willing to let her help. We will address this also next month.
